MINUTES REGULAR MEETING South Farmingdale Board of Fire Commissioners July 12, 2023

At 6:00 PM Commissioner Suwalski called the meeting to order, Commissioner Purpora recited the Pledge of Allegiance, followed by a moment of silence.

Commissioner Ed Purpora, Commissioner Gary Forry, Commissioner Jeff Tasch, and District Secretary Karen Green were present. Attorney Joseph Pusateri, Esq. was present as well. Dr. Jorge Gardyn was present as well.

New Applicants Dolly Shah and Vincent Grauso entered the meeting at 6:05 p.m. and was sworn in by Commissioner Suwalski. They were escorted by Chief George McFarlane, Lieutenant Sturm, their families, and other department members.

The Board entered into Executive session at 6:40 p.m. to discuss a personnel matter. Commissioner Fred Heffel entered the meeting at 6:45 p.m.

The Board exited Executive session at 7:00 p.m. and the Chairman conveyed a response to a recent letter from the District Secretary regarding her hours as recorded in Executive Session minutes of January 10, 2023 and confirmed that the BOFC voted to allow her to come in on the second and fourth Wednesdays later using the time she accrued from the meeting the night before.

The Chairman conveyed that the policy states the workday is 9 a.m. - 5 p.m. and that the designated lunch hour was 12 noon - 1 p.m. daily.

The District Secretary inquired as to why there is a designated lunch hour (12 -1 p.m.) and that she had been mandated to take lunch at that time. The Chairman answered that is when our District Office is closed for business, and they advised the vendors of that.

The District Secretary reminded the Chairman of a conversation at the January 10th, 2023, meeting about taking an early or late lunch in the event of needing to come in late or leave early in the event of a doctor's appointment. Commissioner Heffel stated that this is not a weekly event, and it has to be requested in advance.

District Secretary questioned the BOFC regarding the BOFC's recent removal of her in-house title and inquired as to the impetus for it.

Additionally, the District Secretary inquired as to why she received a letter requesting that she remove her Master of Public Administration (MPA) designation from her signature line. Commissioner Suwalski related there was a former employee that took the liberty of changing his title to District Manager without asking or receiving board

approval and that District Secretary at the time was very much against that employee doing so.

There was no Treasurer's Report.
