#### **Chief's Report:**

#### 1. Personnel

<u>Apparatus – Commissioner Forry</u> 971: Commander Fleet picked up 971 today to do a PM inspection on it.

**975**: Commander Fleet picked up the Fire Police vehicle to check the left rear tire area for a burning smell. They found a leaking axle seal and repaired it.

**976**: Transmission fluid dip stick and/or tube needs to be replaced.

**978**: Left rear outer tire dismounted from the rim. Had road service come and remount the tire at headquarters.

9701: Had a New York State Inspection, oil and filter change done on March 31.

9703: Had an oil and filter change done on March 14.

**9711**: The left rear tire was unrepairable because the sidewall was damaged.

Commissioner Fullshire, Commissioner Mackie, and Commissioner Forry went to Brandon, South Dakota to do a final inspection of the heavy rescue vehicle.

The change order resulting from the final inspection on the heavy rescue vehicle will cost an additional \$4,162.32. There are six additional items to be done and one item to be deleted.

Commissioner Forry received a proposal from Red Truck Sales for the three vehicles. Their proposal is to broker these units at a 10% commission calculated on the final sale price.

I am also working on obtaining project proposals for the fence and parking lot.

Richard Security sent over their quote for the CO Meters. I suggest we do it ourselves because they are battery-operated and are not tied to the alarm system. The CO meters need to be in a few spots in common hallways. They cannot be in any room that has gas appliances.

# **Communications & Alerting - Commissioner Mackie**

Timmy Mooney will be installing radios on the new apparatus vehicles when they arrive. Commissioner Forry recommended that Timmy go out to Hendrickson to see what wires were run into the L1 compartment for radio mic. I met with our radio vendors last Wednesday at Station 2 regarding our backup repeater. I am obtaining quotes in the instance that Headquarters loses power or we have radio failure. We will put policies into place for this type of situation.

# <u>District Reports, Communications & Petitions – District Secretary</u>

The records management grant was submitted on March 31, 2025.

The special election to establish reserve funds will take place April 15, 2025 from 6pm to 9pm.

We received invitations to East Farmingdale, North Massapequa, Hicksville, and Plainview's annual inspection dinners.

### **Emergency Preparedness – Commissioner Tasch**

The house maintainer is going to pick up 10 cases of water. We will be stocked up for county school next month.

#### **Equipment – Commissioner Suwalski**

Members must follow the proper protocol for uniform alterations.

The EMS gear has arrived and has been distributed to the members.

Single gas disposable meters have been placed in service. The new apparatus vehicles 971, 973, and 979 will need some updated equipment. Some of our vehicle equipment is outdated and needs repair. Commissioner Fullshire has offered to assist in tool mounting to save funds.

### Fuel – Commissioner Tasch

Invoices submitted for March. Receipts are coming in. The chiefs need to be submitting their receipts on time.

#### IT Computers / Printers / Cable - Commissioner Mackie

Atlantic PC was here this past week to go through our computers to see which devices were compatible with Windows 11. They also created a new master list of all our computers. It was suggested by Atlantic PC that we replace the treasurer's laptop for a newer model as his current machine is out of warranty.

#### <u>Insurance & Personnel – Commissioner Tasch</u>

Terrorism and Natural Disaster Refund checks have come in: \$1,833.26 & \$36,305.01.

The board of fire commissioners has requested applicant 2025C to come in for an interview on April 22, 2025.

#### Legal / Government - Commissioner Suwalski

Nothing to report.

#### **LOSAP – Commissioner Tasch**

Members have been fingering in for more meetings and trainings than they are attending. This matter has been addressed with the Chief of Department. One member is now receiving LOSAP. I spoke with Tony Hill in regards to increasing the defined benefit from \$700 to \$1200 max threshold. I feel that even with the extra funds I have been putting into

the Defined Contribution Plan (old plan), we would still have enough in the budget to cover this. This matter will be discussed in further detail at a later date.

#### Miscellaneous:

The planning for the installation dinner is coming along nicely. Thanks again to the district manager and secretary for all their help with the preparations.

We will be having a follow-up meeting with the Long Island Railroad about the recruitment banner. They have approved the banner and have provided us with specific measurements. Once it is completed, we will work together to have it installed in a designated area.

Farmingdale Summit for recruitment and community involvement will take place April 26<sup>th</sup> from 12 pm to 2:30 pm. Commissioner Tasch has asked the chief for a truck and a crew.

#### Physicals / Medical Screenings - Commissioner Tasch

There are three (3) members on leave who have not completed their physicals. One (1) has an appointment set up, but the other two (2) will need to have their physical before returning to active duty.
