1. Personnel

- According to our records, there are three members on medical leave. One
 ex-chief completed his physical, but the chief's office has not been advised
 of his status by either the board or the member.
- It is my understanding, after speaking with the district lawyer at the last department meeting, that a member who is currently receiving a disability pension can remain as an active member of the department if they can pass their physical from the district physician. We have one member who we believe falls into this category, as he was deemed a class B member by the doctor.

2. Training and Preparedness

• The training committee has been working hard to provide the membership with better training to ensure they can learn and improve their craft.

• The department is attending Department Operations at the Nassau County Fire Service Academy on Thursday evenings this month. We are currently in week three (3) of four (4).

3. Vehicles and Equipment

Audit & Bonds

Status quo

Buildings & Grounds – Commissioner Fullshire

The garage door at headquarters has been repaired. The sink in the men's bathroom downstairs will need to be replaced. We are looking to purchase a new gas grill for the department. The one we currently have is rusted and no longer usable. New flags and flagpoles have been ordered. We will need to compile a bid specification for the roof. The Neiderman Exhaust system was serviced by Air Purifiers Inc. and is now in working order.

We received two quotes to remove the fence and asphalt as discussed. We were quoted at \$9,000.00 and \$7,250.00. The quotes include removing the step, concrete curb and slab outside of existing rear door. It also includes building new paver steps and walkway to the grass area and gate.

Commissioner Forry received a quote from Allmark Door for the front entrance exterior and interior door repairs. The total cost of the quote was \$5,798.47. The cost includes installation of new sweeps, weatherstripping, and closers on the four existing doors.

Commissioner Forry ordered the 24" wreath for the Department Memorial for the Memorial Day Ceremony at headquarters.

<u>Capital Improvements – Commissioner Fullshire</u>

CCM Roofing has sent us a proposal.

Communications & Alerting – Commissioner Mackie

We are waiting on the delivery date of the two new engines and the heavy rescue vehicle so that I can set up the radio installation on those vehicles. We need to discuss the installation of mic wire to the fire compartment on engines for high-band radio. Our high-band UHF channel went down on Saturday morning at headquarters. I met with Eastern Communications, and they resolved the situation. The light path server needed to be reset. In the meantime, we were on a backup repeater that Firecom has in place for emergencies.

<u>District Reports, Communications & Petitions – District Secretary</u>

We received an invitation to the Bethpage Fire District Installation Dinner.

We received information about applying for the State Farm Good Neighbor Safety Program Grant. This grant provides \$10,000 to local fire departments to purchase necessary equipment. Please look through the eligible equipment list and let the district manager know if the department could benefit from any of those items.

There are five (5) conferences being held in 2025. Please let us know by the end of the week if you would like to attend.

Emergency Preparedness – Commissioner Tasch

All stocked for the final weeks of County School.

Equipment – Commissioner Suwalski

Firefighters' equipment has returned a firefighter's jacket that needed repair.

Commissioner Fullshire has received a quote for new Hurst tools. Handlights and two (2) new Pak trackers were ordered for the new apparatus vehicles. A half-sked was ordered for the 979. The truck company is requesting a 9-inch Dewalt cut-off saw.

EMS hat shields have been ordered. We currently have enough EMS coat shields. New EMS gear was distributed to the members of the EMS squad. The overstock gear was placed into inventory at Station 2.

Uniforms from the closet have been handed out to members, and we have received a list from the department secretary of those members who need new uniforms.

When a member resigns or is terminated, all gear needs to be returned to the Board at the same time. The Board will provide a tote to be placed in the chief's office to gather all items.

Fuel – Commissioner Tasch

Fuel paid for April. Fuel receipts must be turned in before the end of each month.

IT Computers / Printers / Cable – Commissioner Mackie

The CAD interface to the PCR program was knocked out when Atlantic PC rebooted the main server. Repair was completed on a conference call between Commissioner Mackie, the vendors, and Captain Sturm.

Insurance & Personnel – Commissioner Tasch

Two (2) members have returned from educational leave, and two (2) members have recently resigned from the department.

Legal / Government - Commissioner Suwalski

Commissioner Suwalski proposes that the district should hire a proctor to conduct annual assessments on all active members to ensure that they are able to meet the physical qualifications to remain in their roles.

LOSAP – Commissioner Tasch

Checks have been mailed to members who are over 62 and have fulfilled their 2024 requirements.

The additional contribution to the Defined Benefit fund has been completed.
